This application form includes green composts, organic composts from separate doorstep collection and other composts from extraneous material.

No application for approval need be made by farms intending to use their own compost and solid manure.

When the compost is produced, the only material used is aggregates which are listed as permitted in Naturland's production standards (ref. Appendix 1: Permissible Fertilisers and Soil Improvement Agents).	The nutrient balance (N, P, K) or nutrient comparison is acceptable. (Please submit the annual nutrient budget for your farm with this application.) The last soil analysis should be no older than 3 years. (Please submit with this application.)
no use of GMO vegetation or aggregates in the compost	The specifications in the standards governing the greatest quantity of fertiliser permissible are to be observed. 20% of the overall level of N in the compost will be offset, at a maximum of 30 t/ha as dry matter in 3 years in the case of composts of certified quality and otherwise 20 t/ha as dry matter.
Composts may only be applied if their safety with respect to residues is assured. The compost must be tested for contamination with heavy metals (maximum dry weight content in mg/kg: cadmium: 0.7; copper: 70; nickel: 25; lead: 45; zinc: 200; mercury: 0.4; chromium (total): 70; chromium (VI): no trace). The tests must be performed at least once a year. The test results are available. (Please submit them with this application.) Compost from organic waste may only be used if the compost plant complies with Naturland's QA criteria. (Please submit proof/analyses along with this application.)	Please contact the compost producer to clarify any requirements to notify the appropriate authorities before using their compost for the first time. If the composts are not of certified quality, it is necessary to analyse the soil for heavy metals.
